# **Executive summary**

#### **Environment**

- 3. Our <u>Environmental Policy</u> details a number of objectives through which we aim to manage and, where possible, reduce any impacts on the environment that are due to our activities. Generally, we are committed to improving the environmental performance of our organisation, which involves protecting biodiversity, reducing pollution and carbon emissions.
- 4. We also continue to be committed to improving efficiency in how we function as an organisation and in how the office is managed and in 2020-21 we:
  - changed our working practices to allow staff to work remotely as they were unable to access the office premises due to the impact of the COVID-19 pandemic
  - adopted a no-paper policy when working remotely
  - used telephone and video conferencing to replace in person face to face meetings
  - selected the most environmentally friendly products for cleaning where possible.

## Sustainability

5. Under the Public Services Reform (Scotland) Act 2010, Section 32(1)(b), as soon as practicable after the end of each financial year, we must publish a statement of the steps we

have taken during that financial year to promote and increase sustainable growth through the exercise of our functions.

- 6. The Commissioner's primary function is to enforce and promote Scotland's freedom of information legislation. Promoting and increasing sustainability is a challenge as we are a small, single site organisation. However, our office can make a direct contribution to sustainability through the management of its carbon footprint.
- 7. We remain committed to managing and, where possible, further reducing our carbon footprint and will continue to seek ways to do so.
- 8. The Statement on sustainable growth 2020-21, which will be published following approval by the SMT, is attached.

## **Carbon footprint**

- 9. The total organisation CO2e for 2020-21 is 18.36 tonnes compared to 32.44 tonnes in 2019-20 as demonstrated in Appendix 1, this is significantly below our annual target of 40.5 CO2e shown graphically in Appendix 2.
- 10. This decrease has been mainly due to the impact of the COVID-19 pandemic affecting our organisation as we had to change our way of working. We followed government guidance to close the office premises and, throughout the year, only essential work has been allowed to take place in the office premises, mainly involving a weekly essential visit by members of the Corporate Services Team. This resulted in our electricity and gas usage being considerably lower than in past years.
- 11. The CO2e conversion factors were realigned this year by the Scottish Government (this occurs every five years) and this has resulted in a considerable reduction in the CO2e created from electricity, due to more environmentally friendly renewable sources of energy being in place. This realignment has had a positive impact and helped to reduce our carbon footprint in 2020-21.
- 12. Throughout 2020-21, there were no meetings held in person and, therefore, almost no journeys resulting in an almost 100% reduction in CO2e, in this category, from 2019-20.
- 13. Due to the change in working practices, with all staff working remotely with remote access to our office systems, staff have not needed to use as much paper as in previous years, for example, paper copies of case files have not been needed. As a result of this, our shredding needs have reduced by 25% from previous years.

# Risk impact

- 14. We are required to promote and increase sustainable growth and by actively managing our carbon footprint and reporting on the same we mitigate the operational risk of not doing this.
- 15. This CR and the publication of the C1 Statement on sustainable growth mitigate governance risks,


