Purpose of report

1. To report on performance of the Scottish Information Commissioner's website in 2021-22.

Recommendation and actions

- 2. I recommend that:
 - (i) The Senior Management Team (SMT) notes the contents of this report and the attached paper
 - (ii) SMT note that the Commissioner's new website was launched on 7 April 2022 and therefore the figures reflected in this report relate to the Commissioner's old website.
 - (iii) This report and attached paper are published in full as set out in the publication section below.

Executive summary

- 3. Each year traffic and usage of the Scottish Information Commissioner's ('the Commissioner') website <u>www.itspublicknowledge.info</u> is reported.
- 4. Across 2021-22, key statistics highlight:
- 5. Overall traffic to the website has increased across the year (Sessions [121,907] by 33% and users [78,762] by 38%). The proportion of new visitors to our website (compared to returning visitors) has also increased, slightly, compared to 2020-21, now at 88% compared to 86%.
- 6. The most viewed sections of the website were Home/About Us, The Law, and Scottish Public Authorities. This is in keeping with 2020-21. The Covid-19 Info Hub landing page has dropped out of the top 10 most viewed pages.
- 7. Traffic on the decisions section of the website has increased significantly over the last year (likely due to decisions being uploaded regularly now after disruption arising from the pandemic). Unique page views for the decisions database increased 15-fold across 2021-22 compared to 2020-21.

Risk impact

8. The website is the Commissioner's principal communication tool. The risks associated with lack of effective communications are identified within existing risk management mechanisms, and are mitigated by actions set out in our communications planning and strategy tools.



Equalities impact

- 9. Across 2020-21 work took place to identify and address issues regarding accessibility of the Commissioner's website for as many people as possible, in line with requirements of the Public Sector Bodies (Websites and Mobile Applications) (No. 2) Accessibility Regulations 2018. Work is underway to review the Commissioner's Accessibility Statement to reflect significant improvements made in the production of the new website launched on 7 April 2022. Activity in this area will continue.
- 10. It is noted that not all people in Scotland can or wish to use the internet, and as a result the Commissioner provides information in alternative formats including via the enquiries service, wherever possible.

Privacy impact

11. No new privacy implications arise from this report.

Resources impact

12. The old website was maintained within planned operational resources, and the content of this report does not in itself give rise to any additional resource impact.

Operational/ strategic plan impact

13. The performance of the Commissioner's website is critical to delivery of a range of strategic and operational priorities. This report's findings do not highlight any new impacts.

Records management impact (including any key documents actions)

14. None identified.

Consultation and Communication

15. Relevant policy and information officers have been involved in preparation of the report. This report provides annual detail to the SMT about performance of the Commissioner's website.

Website Statistics Report 2021-22

Introduction and key findings

- 1. This report provides statistics for the Scottish Information Commissioner's website (www.itspublicknowledge.info) for the period 1 April 2021 to 31 March 2022.
- 2. Traffic to the website has increased across the year (Sessions by 33% and users by 38%). The proportion of new visitors to our website (compared to returning visitors) has increased slightly compared to 2020-21, now at 88% compared to 86%.
- 3. The most viewed sections of the website were Home/About Us, Law, and Scottish Public Authorities, which is in keeping with 2020-21. Page views, for every page in top 10 have nearly doubled compared to views in 2020-21 and, over all, there has been a 76% increase in page views in 2021-22.
- The decisions section of the website appeared back in the top 10 in 2021-22, after the disruption of the pandemic impacted on the availability of decisions on the website in 2020-21. Unique page views for the decisions database was 15 times higher in 2021-22 than 2020-21.

Visitor volumes

- 5. Visits and users on the site have increased over the year by 33-38%.
- 6. There has also been another significant increase in page views up by 76% on 2021-22, and the number of pages viewed per sessions has risen by 33%.
- 7. This is highlighted by the proportion of new (88%) to returning (12%) visitors to the site.

8. New user behaviour was similar to that observed in previous years e.g. they viewed fewer pages than returning visitors, spent shorter period of time on the site and were much more likely to leave the site from their initial landing page.



- 9. The most viewed sections of the website were Home/About Us, Law, and Scottish Public Authorities. This is in keeping with previous years. Overall page views for the year have increased by 76%.

12. Page views for all sections of the website in 2020-21 were undoubtedly affected by the impact of the Covid-19 pandemic, so it encouraging to see there has been a significant improvement during 2021-22.

Decisions section

13. The Decisions section of the website accounted for 12% of website views this year, having accounted for 9% last year and 10% the previous year. Most notably, page views of the decision section have risen by 70% compared to 2020-21

14. Traffic to individual pages for reports, consultation responses and news releases over the year are listed in the table below. Those that drew notable traffic are:
